About the Library

The School of Social Sciences Library is functioning in the main building of the School of Social Sciences in an area of 3950 sq. ft. The SSS Library houses a collection of 13,000 documents, including books purchased annually, books received as gifts, bound volumes of journals, a reprographic collection, and archives. Matthew Kurian collection, theses, MPhil dissertations, postgraduate project reports, multimedia collections. Besides this, the library has access to online journals and databases subscribed to by the University Central Library

1.Books

Yearly books purchased using the budget provision are added to the library collection. Books selected by the faculty from the publisher catalogue are mainly included in the purchase list. A book suggestion register is available in the library. Books suggested by research scholars, MA students, and all library users are also included in the purchase list.

The Book Purchase Committee of SSS finally decides the list of books to be purchased for the SSS Library every year.

2.Shungoony Menon collection.

The library maintains a closed reference collection under the name Shungoony Menon Collection. The books were donated by the family of Shungoony Menon, mainly containing his personal library collection. Shungoony Menon is a historian who laid the foundation of the history of Travancore in his treatise, The History of Travancore, published in 1878. This rare collection of library materials includes the following archival materials on Travancore's history.

1.Report on the Administration of Travancore, from (61 volumes)

Official publication of Govt of Travancore ,which throws light on Legislation, Judicial administration, Sources of revenue,Health, Education, Agriculture, Industry,Economic Development,Labour,Public Works,Electricity, Trade etc. in the Travancore Kingdom, i.e. independent Kerala.

2. Travancore legislative council proceedings 1922 to 1943. Covers Question Answers of Travancore Legislative Council

3.Mathew Kurian Collection

The library maintains a closed reference collection of 2000 rare books under the Mathew Kurian Collection. The personal library collection, including the rare books of Dr.Mathew Kurian, was gifted by his family after his death.

4. Publications of Social Sciences

Books authored by faculty of Social Sciences are prominently displayed.

5.Archives

In addition to the archive available in the Shungoony Menon collection, the library maintains a special archive collection mainly related to historical documents of Travancore and Cochin states.

6. Books gifted by Alumni of SSS

The library has a special collection of books gifted by Alumni of the school.

Classification scheme in the Library

Dewey Decimal Classification is being used for classification and arrangement of books. Using this scheme a unique

Call number is provided to each book and according to the Call number, books are arranged in the shelves. Call number is like an address. It tells us where the book is in the Library.

Call number has two parts. First part is the Class number used to classify library resources by subject area.

The second part is Book number which takes up the individualisation further.

Example: Books on Indian history as arranged on the shelf.

Here 954 is the Class number for the subject Indian history

As 6 books bear the same class number 954, the books are further arranged alphabetically on the basis of the first three letters of the author i.e. the Book Number.

2.EBSCO Academic Search Primer (https://search.ebscohost.com/)

A multi-disciplinary database of more than 4,600 magazines and journals, including full text for nearly 3,900 peer-reviewed titles. In addition to the full-text, this database offers indexing and abstracts for 8,470 journals.

Search alerts in EBSCO

After registering a free account in EBSCO, users can avail Saving search strategy and, Create alert.

Select **Alert** is to receive an e-mail each time new items that meet our search Wcriteria are added to the database in which we have run the search. This can help us keep up to date without having to return to the database and re-run our search to check for new results. We can specify our desired options and enter the e-mail address and a subject line.

3. EPWRF India Time series. An initiative taken by the EPW Research Foundation with an aim to provide time series data facilitating research across various sectors of Indian Economy.

The EPWRF India Times Series (EPWRFITS), an interactive online database which provides credible time series data facilitating research across various sectors of the Indian Economy.

A time series is a data set that tracks a sample over time. In particular, a time series allows one to see what factors influence certain variables from period to period. Time series analysis can be useful to see how a given asset, security, or economic variable changes over time.

Example:Household indebtedness on various social groups over a period. Wage rate in India over a period.

The database covers Indian economy for a fairly long time period and it comprises over 30,000 variables capsuled in 16 modules. The database provides in continuous time series

from 1950 depending on the availability. The subscription access is provided by CESP, JNU using funds from its CAS programme.

A rich collection of citation indexes representing the citation connections between scholarly research articles found in the most globally significant journals, books, and proceedings in the sciences, social sciences, and art & humanities.

Information services.

The core functions of Information Services include selecting and acquiring relevant resources, organising and cataloguing information for easy retrieval, assisting users in locating and using information effectively, and promoting information literacy and research skills among community members.

Reference Services.

Reference service is the personalised service directed towards the users. Reference services provide library users with direction to the library materials, give advice on library collections and services on various kinds of information from a variety of sources. Reference department basically helps users to answer the questions that the user has in mind as well as helping the user to locate the information that they need in the library.

1) Information services that involve either finding the required information on behalf of the users, or assisting users in finding information.

2) Instruction in the use of library resources and services is broadly defined as information literacy skills. By providing information literacy skills, the library user is made capable of critically evaluating the content for credibility, accuracy, and relevance.

2.Referral services. A type of reference service in which an information seeker is directed to an agency or expert outside the library where information may be obtained.
